The Uplifting Parents program was created in 2014 to empower single parent families by providing resources to support their advancement in education.

UP provides one-on-one mentoring, financial resources, case management, parenting support, and facilitates a community of support to single parents pursuing a post-secondary degree or certificate.

Hope, 23 and single mom attending Western Dakota Tech for Laboratory Technician, was accepted into the Uplifting Parents program in 2022. With her demanding school schedule and lack of comprehensive childcare, she was unable to work to provide for her family during her time in school. She graciously accepted benefits that would carry her through this season while she worked hard on her degree to overcome the need for them, although not without guilt. Like many UP participants, Hope had little support through her school journey, making it a lonely one. Yet, her passion fueled her to keep pushing through one roadblock after another.

Through the support of UP, Hope was able to secure safe, reliable, and complementary childcare for her daughter. This unlocked new possibilities and Hope shined in her clinicals. She secured gainful employment by the time graduation rolled around. Hope is the first to graduate college in her family, and she is crushing her goals. She and her daughter are no longer on public benefits, and she recently received news she has been approved to buy her first home.

Uplifting Parents has nearly completed the research required for the data collection with the Wilson Sheehan Lab for Economic Opportunity (LEO). The preliminary results are outstanding, displaying a graduation rate of 76% for UP participants compared to the national average rate of 50%. With the research backed evidence illustrating the success of the UP program, the next step is replication.

“The UP team continues to work with LEO to scale and franchise the program to positively impact single parent families in other communities throughout the nation, helping them to also overcome the cycle of poverty.”



Trinity Pregnancy and Adoption

Lakota Circles of Hope is a proven 10-week, culturally based, prevention curriculum that uses South Dakota values to teach students how to deal effectively with risky behaviors through Lakota traditions and culture.

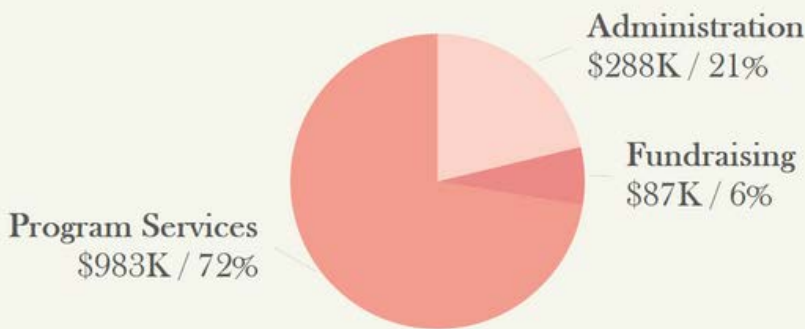


CSS Fiscal Overview
